4) NOTIFICATIONS AND DECISIONS

At the match of 10th round between HC NEXE and HC CROATIA OSIGURANJE, played in Osijek, Nexe player Luka Sokolić was disqualified in 29th minute of the game.

Due to the resulting disqualification, in accordance with Article 99 of the Competition Regulations, SEHA League Commissioner brought up the following

DECISION

HC NEXE player Luka Sokolić is fined 100 €

LEGAL REMEDY NOTE:

To the decision of the Commissioner of the league it is possible to appeal to Competitive Commission as an appellate authority, within 24 hours of receipt of the decision, in accordance with Article 42 of the Regulations SEHA League. With the appeal should be paid a fee in the amount of € 1,000 to the account of SEHA League, according to Article 43 of the SEHA League Regulations.

At the match of 10th round between HC VOJVODINA and HC PARTIZAN, played in Novi Sad, Vojvodina player Uroš Elezović was disqualified in 59th minute of the game.

Due to the resulting disqualification, in accordance with Article 99 of the Competition Regulations, SEHA League Commissioner brought up the following

DECISION

HC VOJVODINA player Uroš Elezović is fined 100 €
