4) NOTIFICATIONS AND DECISIONS

On October 25th2014. in Novi Sad was played match of the 7th round Seha Gazprom South Stream League between HC Vojvodina and HC Nexe. After a supplemental statement of the SEHA League delegate Mr. Aco Niolovski, due to the breach of Article 66., League Commissioner has decided as follows:

HC VOJVODINA is punished by a fine of 500 € (five hundred euros)

On October 25th2014. in Novi Sad was played match of the 7th round Seha Gazprom South Stream League between HC Vojvodina and HC Nexe. After a supplemental statement of the SEHA League delegate Mr. Aco Niolovski, due to the breach of Article 75., League Commissioner has decided as follows:

HC VOJVODINA is punished by a fine of 500 € (five hundred euros)

On October 25th2014. in Novi Sad was played match of the 7th round Seha Gazprom South Stream League between HC Vojvodina and HC Nexe. After a supplemental statement of the SEHA League delegate Mr. Aco Niolovski, due to the breach of Article 100.4., League Commissioner has decided as follows:

- HC VOJVODINA is punished by a fine of 1.000 € (one thousand euros)

On October 25th2014. in Novi Sad was played match of the 7th round Seha Gazprom South Stream League between HC Vojvodina and HC Nexe. After a supplemental statement of the SEHA League delegate Mr. Aco Niolovski, due to the breach of Article 98., League Commissioner has decided as follows:

- HC VOJVODINA is punished by a fine of 2.000 € (two thousand euros)
- to HC Vojvodina president Mr. Milan Djukic was imposed a ban on performance of duties in handball sponsored by SEHA League for a period of 6 months (six months)

On November 5th, 2014. in Zagreb should have been played a match between HC PPD ZAGREB from Zagreb and HC Metalurg from Skopje.

On the scheduled match team Metalurg has not arrived.

After collecting of statements and evidence, from both teams, League Commissioner delivered the following decision:

- 1. The match is registered with the official result of 10:0 for HC "PPD ZAGREB" Zagreb, according to Article 87 of SEHA League Proposition.
- 2. HC "Metalurg" is punished with an amount of € 2.000 according to Article 87 of SEHA League Proposition.
- 3. HC "Metalurg" is penalized by deducting one point according to Article 87 of SEHA League Proposition.
- 4. HC "Metalurg"has to pay to HC "PPD ZAGREB" amount of € 8.616 for the costs of organizing match. (middle exchange rate of 66.000 kuna on the match day) according to Article 87 of SEHA League Proposition.
